PROTOCOL II SITTING OF THE SECOND PARLIAMENT OF ASGARDIA 13-15 LIBRA, 0007 (25-27 August 2023)

TYPE AND LOCATION

The 2nd Parliamentary Sitting of Second Parliament of Asgardia was held on 13-15 Libra 0007 (25-27 August 2023) in the form of digital presence, using platforms ZOOM, SLACK and the electronic voting system of Asgardia.

REGISTRATION AND QUORUM

Registration was carried out on the digital platform of Asgardia.

At the time of the registration, the Parliament constituted **147** members (AMPs), who were authorized to be admitted to registration and voting.

Registration, corresponding to the report of the Mandate Commission **104** parliamentarians (AMPs), was 71%, exceeding the required quorum total of 50% + 1 Asgardian Members of Parliament.

The quorum was achieved.
