PROTOCOL VI SITTING OF THE SECOND PARLIAMENT OF ASGARDIA 26-28 SCORPIO 0008 (04-06 OCTOBER 2024)

TYPE AND LOCATION

The VI Parliamentary Sitting of Second Parliament of Asgardia was held on 26-28 Scorpio 0008 (04-06 October 2024) in the form of digital presence, using platforms ZOOM, SLACK and the electronic voting system of Asgardia.

REGISTRATION AND QUORUM

Registration was carried out on the digital platform of Asgardia.

At the time of the registration, the Parliament constituted **146** members (AMPs), who were authorized to be admitted to registration and voting.

Registration, corresponding to the report of the Mandate Commission **90** parliamentarians (AMPs), was 62%, exceeding the required quorum total of 50% + 1 Asgardian Members of Parliament.

The quorum was achieved.
