

Final Round of the First Asgardian Parliamentary Elections

Introduction

Asgardia's Administration and the Central Electoral Commission (CEC) thanks everyone who applied as a candidate to the Asgardian Parliament, and all those who took part in voting in the primaries. Based on the votes in the primaries, the final round of the first Asgardian parliamentary elections will be organised, and votes will be counted.

For the first elections, the CEC decided to allow participation for those candidates who are unable to pay the registration fee for whatever reason (whether due to the time constraints or logistical limitations). However, the final approval for becoming a Member of Parliament will be possible only when the required number of votes is received and the registration fee is paid before 1 April 2018 (7 April 0002 by Asgardian calendar).

- 1. In each district, the list of the candidates will be divided into two parts. The first part will include all the candidates who submitted all the required information in the application form and paid the registration fee before midnight 28 February 2018 (3 March 0002). The second part will consist of the candidates who have submitted all the required information in the application form and have sent a letter with as guarantee of payment before midnight on 9 March 2018 (12 March 0002), and committed to payment by 1 April 2018 (7 April 0002).
- 2. In each part, the order in which the candidates are listed on the voting page is determined by the results of their primaries. Those with the most votes in each part of the list are placed on the top.
- 3. In case two candidates have the same number of votes in the final round, and they both paid the registrations fee, the number of votes in the primaries will be taken into account to determine the winner.
- 4. Each Asgardian has the right to vote in every district for as many candidates as there are seats in the respective district.
- 5. Voting can only be done directly (personally). You are not allowed to give your vote to another Asgardian or to vote in his/her name.

- 6. Voting is set for default anonymity. However, if an Asgardian would like the parliamentary candidate(s) to know that he/she voted for them, a respective mark should be placed in the voting page in front of the name of each candidate individually "I want my vote to be visible to the candidate".
- 7. Only members of the Counting Commission and the auditors have access to the voting log files.
- 8. The list of the Members of the Parliament will be determined on the basis of the results of the voting that takes place in the period 1-9 March 2018 (4-12 March 0002), by 1 April 2018 (7 April 0002).
- 9. The final list of the Members of Parliament will be published only after personal meetings with each of them, verification of their profile data on the basis of the personal documents, and the confirmation of payment of the registration fee.
- 10. For those who won the elections and paid the registration fee, or provided a letter of guarantee in accordance with the attached sample, an economy class trip to Vienna and accommodations for the first meeting will be paid for by Asgardia.
- 11. For those who cannot travel for whatever reason or for those who for objective reasons cannot pay the registration fee on time, the CEC will grant special agreement for a delayed registration fee payment on a case-by-case basis. In order to apply for such an agreement, please write to director@asgardia.space. Make sure to put the following in the subject line: ELECTIONS to Parliament. District XX, FIRST and LAST name.
- 12. All the issues related to the medical insurance for the travel, visa support for Austria, etc., will be addressed only after 1 April 2018 (7 April 0002), once the results of the voting are published in a Decree by the Head of Nation.

Asgardia reserves the right to run an international criminal record check on everyone who wins the elections. The agreement for the criminal record check will have to be given by the prospect Members of Parliament after the election results are official. It is required that every prospect Member of Parliament provides Asgardia with an official statement that is not older than two weeks issued by respective authorities of the country of residence that he/she has no criminal record. Every elected Member of Parliament will have to sign a statement that he/she is not currently accused of any crime anywhere in the world and is not a subject to any ongoing criminal investigation. A clean record is a requirement to be member of parliament of Asgardia.
