### THE REGULATIONS ON HOLDING BY-ELECTIONS TO THE FIRST PARLIAMENT OF ASGARDIA

10 April 2018 (16 April 0002)

In accordance with Decree No. 16 of the Head of Nation from 1 April 2018 (7 April 0002), the by-elections to the first Parliament of Asgardia will take place from 16 April until 16 May 2018 (22 April – 24 May 0002).

The Central Electoral Commission (CEC) has approved the Regulations on holding the by-elections to the first Parliament of Asgardia.

1. Acceptance of candidate applications will reopen on the official website Asgardia.space on 10 April (22 April 0002) and close on 16 May (24 May 0002).
2. To simplify the logistics, and taking into the consideration the unique nature of holding elections and the formation of the first Parliament of Asgardia, the by-elections of the remaining 50 candidates will be held in a singular district.

4. All candidates who, according to Decree No. 16, have not made it to the list of Members of Parliament based on the results of the voting during the period of 1-9 March 2018 (4-12 March 0002), but have met all of the mandatory conditions for becoming elected, confirmed earlier by the CEC, will immediately begin the by-elections in the “Endorsed” section with the retention of the votes they had received earlier.
5. All candidates who, according to Decree No 16, have not made the list of the Members of Parliament based on the results of the voting during the period of 1-9 March 2018 (4-12 March 0002), and who, along with other mandatory conditions, have paid or will pay the mandatory registration fee after 1 April (7 April 0002) and no later than 16 April (22 April 0002), will also be transferred into a singular district in the “Endorsed” section without retention of the votes they had received earlier.

6. The applications of all previously registered candidates are annulled with the possibility of undergoing the registration procedure for their candidacy in the by-elections to the Parliament of Asgardia once again, beginning on 10 April (22 April 0002).
7. New candidates for Parliament are required to present their ID and upload a profile photo and CV during registration.
8. Letters of guarantee are not accepted during the by-elections. As soon as the Elections Office confirms receiving a payment of the mandatory registration fee in the amount of 100 Euros, the candidate who has met this condition is moved to the “Endorsed” section.

A confirmation of payment of the registration fee after the conclusion of the final date of the by-elections, i.e. after 16 May (24 May 0002), will not be accepted by the CEC during the review of the results of the by-elections.

9. Every Asgardian has the right to vote for no more than 50 candidates, based on the number of vacant seats in the by-elections to the Parliament of Asgardia.
10. Voting can only be done directly (personally). You are not allowed to give your vote to another Asgardian or to vote in his/her name.
11. Only members of the Counting Commission, the CEC and independent auditors have access to the voting log files.
12. The results of the by-elections and the list of the elected candidates based on the results of the voting period from 16 April to 16 May (22 April – 24 May 0002) will be presented for review by the Head of Nation by 20 May (28 May 0002).
13. The final list of Members of Parliament will be confirmed by the Head of Nation only after the verification of their profile data (based on the review of their personal documents) by authorised officials of Asgardia.

An important notice for the candidates: holding positions in both the Parliament and the Government is not permitted.
