

## PROTOCOL

5th PARLIAMENTARY SITTING OF ASGARDIA
11-13 VIRGO 0003 (26-28 JULY 2019)

## TYPE AND LOCATION

The 5th Parliamentary Sitting of Asgardia was held on 11-13 Virgo 0003 (26-28 July 2019) in the form of digital presence, using platforms ZOOM, SLACK and the electronic voting system of Asgardia.

## Registration and Quorum

Registration was carried out on the digital platform of Asgardia.
At the time of the registration, the Parliament constituted $\mathbf{1 1 0}$ members (AMPs), who were authorized to be admitted to registration and voting.

Registration, corresponding to the report of the Mandate Commission 107 parliamentarians (AMPs), was $\mathbf{9 7 , 2 7 \%}$, exceeding the required quorum total of $50 \%+1$ Asgardian Members of Parliament.

The quorum was achieved.

a. Parliament approves the investment of funds available to Parliament and Government (if Government will adopt participation in sitting) to pay for a Physical Sitting, if approved for use by an authorized legal entity
b. Parliament recognizes that this money can be an alternative to salary payments for the time being and the sums that should be paid to parliamentarians will be paid when the economy of Asgardia generates sufficient income
c. Physical attendance is NOT mandatory. Any AMP who wishes to attend the Sitting using digital media is permitted to do so. All digital facilities will be available in the same way they are for any Digital Sitting. Digital attendance will be treated as having the same status as physical attendance. Therefore, it is not necessary for AMPs to attend the Physical Sitting, unless they wish to and are able to do so.
d. Travel and accommodation costs will be paid by Asgardia for those, who attend the Physical Sitting.
e. Parliament will consider how to distribute any surplus remaining from the arrangement of the Physical Sitting during the next (after the physical) digital sitting.

"Any legislative proposal shall first be presented to the Chairman of Parliament and the Justice Committee for determination of constitutionality and such determination to be attached to the bill when it is being voted on by the Parliament.
If no determination is attached within 45 days, the legislative proposal may be presented to the Parliament in its original form."

## ITEMS FOR VOTING

## 1. Election of Deputy Chair of Parliament.

## 5. Amendment to Act of Acts, Section 15, Par.2.

To replace in Asgardia Act on Acts Section 15 Paragraph 2:
"Any legislative proposal shall first be presented to the Chairman of Parliament and the Justice Committee for determination of constitutionality of the legislative proposal".

## With

Any legislative proposal shall first be presented to the Chairman of Parliament and the Justice Committee for determination of constitutionality and such determination to be attached to the bill when it is being voted on by the Parliament.

If no determination is attached within 45 days, the legislative proposal may be presented to the Parliament in its original form.

In accordance with the Agenda, the following issues were discussed:
a) Development of the forms and methods of the Parliament's activity in the field of building population and the economy of Asgardia.

To consider inviting AMP Benjamin Dell to collect and develop all proposals and initiatives from relevant and interested Committees of Parliament, and submit these for discussion at the next Sitting of the Parliament as aggregate proposals on the effective forms and methods for the development of Asgardia:

- in the formation of a quality civil society composed of citizens, who are interested in the development of the First Space Nation and are contributing to that;
- in terms of developing the economy of Asgardia by delivering the revenue side of the budget, ensuring there is no budget deficiency, a fair division and targeted use of budgetary funds distributed to all branches of power, formation of local and federal parts of the State budget;
- in operation of transactions made in the currency of Asgardia.
b) Explanation by the Chair of Parliament of the procedure for amending the Constitution of Asgardia initiated by the Supreme Space Council (SSC).

To determine the responsible parliamentarian representatives for the participation and fulfillment of the requirements prescribed by the Constitution and the decision of the SSC.

The decision to prepare a referendum on amending the Constitution of Asgardia, adopted by the Supreme Space Council, is as follows:
a) To start collecting proposals for amending the Constitution of Asgardia.
b) To instruct the Government, Parliament and the Supreme Judge of Asgardia to organize the collection of amendments and additions to the Constitution.
c) To instruct the Ministry of Justice and the Justice Committee of Parliament to systematize and summarize them.
d) Only residents and citizens, who have adopted the Constitution and paid the Citizenship and Resident annual Fee (CRF), have the right to submit proposals for amending and supplementing the Constitution.
e) To organize the acceptance of proposals for amending and supplementing the Constitution by residents of Asgardia on the website asgardia.space.
c) Debates on the legislative proposal 'Domicile Act', which collected 30+ votes.

The purpose of the bill is to clarify the residence of the citizens of Asgardia for the possibility of providing them services and legal assistance in accordance with the legislation of Asgardia. Holding of Parliamentary debates and preparation of the legislation for the approval at the next Parliamentary Sitting.
d) Parliamentary Questions to the Prime Minister of Asgardia.
e) Parliamentary Questions to Ministers and the Government of Asgardia. Parliamentary questions should be submitted according to the following procedure:

1) All Members of Parliament of Asgardia have the right to submit questions through the Administration to various government bodies within the area of their responsibilities and sphere of expertise.
2) Responses to Parliamentary Questions are provided within 28 days of submission.
3) Responses are published as needed and agreed upon by all parties on appropriate informational channels.

## f) Reports by the Committee Chairs of Parliament.

Reports will be made with consideration for the following terms of operation of Committees:

1) The main goals of the committees are:

- Lawmaking
- Evaluation of the proposed legislation.

2) Every Parliamentary Committee devotes most of its attention to their specific area.
3) Every Committee collaborates with the necessary ministries the work of which concerns its particular area, and with the Administration of the Head of Nation.
4) Committees should coordinate their work with the according ministry.
5) All Committees should provide a written report to the Chair of Parliament by 13.00 UTC on 09 Virgo 0003 (24th July 2019).
