ASGARDIA MINISTERS NOMINATION REGULATIONS (0004/2020)

General Provisions

- 1. In order to ensure the full functionality of the governmental institutions of Asgardia it is necessary to form an entire Government of Asgardia: 12 Ministers, and a Chairman of the Government.
- 2. Pursuant to Chapter 8, Article 32, paragraph 1, the Head of Nation of Asgardia is the Guarantor of the Constitution of Asgardia. On the above grounds, and due to the temporary absence of the Government at the moment, Head of Nation approves this Regulations to ensure the formation of the new Government.
- 3. Pursuant to Chapter 8, Article 34, paragraph 3 of the Constitution of Asgardia, the Government of Asgardia shall comprise the Chairman of the Government and 12 ministries corresponding to the relevant parliamentary committees.
- 4. Pursuant to Chapter 8, Article 34, paragraph 4 of the Constitution of Asgardia, the Chairman of the Government shall be appointed by the Parliament on the proposal of the Supreme Space Council in agreement with the Head of Nation. And, pursuant to Chapter 8, Article 33, paragraph 10c of the Constitution of Asgardia, The Parliament of Asgardia appoints Ministers on the proposal of the Chairman of the Government.
- 5. Vacancies for ministerial positions are announced as of Leo 15, 0004 (July 1, 2020), applications from candidates are accepted until Ophiuchus 25, 0004 (October 31, 2020).
- 6. As per Protocol # 6 of the SSC dated Leo 2, 0004 (June 18, 2020), the Head of Administration is defined as responsible for the formation of the Government of Asgardia.
- 7. The SSC shall consider candidates to fill the Members' of Government vacancies until Ophiuchus 25, 0004 (October 31, 2020) and presents the candidacy of the Prime Minister, to be considered at the Parliament sitting in the 4th quarter of 2020.

Requirements for applying for ministerial positions

- 8. Pursuant to Chapter 8, Article 34, paragraph 4, Ministers may be Asgardian citizens aged between 35 and 60 (born between 1960 and 1985), who have a degree, qualifications, and professional experience in a relevant area, and the required physical and mental health to perform the duties of a minister (Prime Minister).
- 9. In order to become a candidate, a resident of Asgardia must submit an application, a CV, and the proposed program of work of the Ministry, including the main directions of strategic development and plans for economic self-sustainment of the Ministry to the email address provided at the end of this document.
- 10. The candidate's resident profile on Asgardia's website must be fully filled out, including the full name, good quality portrait photo and other required information.
- 11. The candidate for the position of Minister undertakes, if appointed to the above position, to participate in digital and physical sittings of the Government of Asgardia and to perform all necessary work to ensure the activity of their Ministry.

Requirements for being nominated as Ministers

- 12. The application of each candidate for the position of Minister will be considered for compliance with the requirements of the Constitution of Asgardia (as described in the section "General Provisions" above) and for compliance with the Requirements for applying for ministerial positions (as described in the relevant section above).
- 13. If the above criteria are met, the candidate will be invited to a personal/digital interview.
- 14. Based on the results of preliminary interviews, the candidacies will be introduced to the SSC members for review.
- 15. In line with Chapter 8, Article 34, p. 4 of the Constitution of Asgardia, the SSC shall forward the candidacy for the Prime Minister position to the Parliament sitting scheduled for the 4th quarter of 2020. In line with Chapter 8, Article 34, p. 4 of the Constitution of Asgardia the Prime Minster proposes the candidacies for the ministers' positions to the Parliament for voting.

Results

- 16. Pursuant to Chapter 8, Article 33, paragraph 10c of the Constitution of Asgardia, the Parliament shall vote on the candidacy of the Prime Minister as well as on candidates for the positions of Minister proposed by him/her at its sitting in the 4th quarter of 2020.
- 17. The Prime Minister and the Ministers approved by the Parliament take office upon signing the non-disclosure agreement.
