# PROTOCOL VII SITTING OF THE SECOND PARLIAMENT OF ASGARDIA 05-07 CAPRICORNUS 0008 (06-08 DECEMBER 2024)

#### TYPE AND LOCATION

The VII Parliamentary Sitting of Second Parliament of Asgardia was held on 05-07 Capricornus 0008 (06-08 December 2024) in the form of digital presence, using platforms ZOOM, SLACK and the electronic voting system of Asgardia.

#### **REGISTRATION AND QUORUM**

Registration was carried out on the digital platform of Asgardia.

At the time of the registration, the Parliament constituted **146** members (AMPs), who were authorized to be admitted to registration and voting.

Registration, corresponding to the report of the Mandate Commission **87** parliamentarians (AMPs), was 60%, exceeding the required quorum total of 50% + 1 Asgardian Members of Parliament.

The quorum was achieved.
