#### XV PARLIAMENTARY SITTING OF ASGARDIA

#### 21-23 ARIES, 0006 (18 -20 MARCH 2022)

#### TYPE AND LOCATION

---

The 15th Parliamentary Sitting of Asgardia was held on 21-23 Aries 0006 (18-20 March 2022) **in the form of digital presence**, using platforms ZOOM, SLACK and the electronic voting system of Asgardia.

#### REGISTRATION AND QUORUM

---

Registration was carried out on the digital platform of Asgardia.

At the time of the registration, the Parliament constituted **135** members (AMPs), who were authorized to be admitted to registration and voting.

Registration, corresponding to the report of the Mandate Commission **110** parliamentarians (AMPs), was **82%**, exceeding the required quorum total of 50% + 1 Asgardian Members of Parliament.

**The quorum was achieved.**
