

## RULES

## On Holding Elections of Asgardia's Mayors

via conference call

The Central Electoral Commission (CEC) affirmed the following rules for holding elections of Asgardia's mayors:

- 1. Mayoral candidates from cities and electoral districts on Earth can submit their applications for running in the elections from 00:00 GMT on August 1, 2018 (July 17, 0002) until 00:00 GMT on September 9, 2018 (August 28, 0002). Applications are being accepted on Asgardia's official website, www.asgardia.space.
- 2. Any resident of Asgardia who has reached the age of 18 can participate in the election. Any persons who have completed all the mandatory fields of the registration profile on Asgardia's official site, including acceptance of the Constitution are deemed to be residents.
- 3. Cities on the planet Earth with at least 100 Asgardian residents can participate in the elections.
- 4. In order for cities with fewer than 100 Asgardian residents to participate in the elections:
  - Mayoral candidates from these cities are to run campaigns aimed at increasing the number of residents in their cities to the minimally required 100 persons. Mayoral candidates from these cities have until 00:00 GMT on September 9, 2018 (August 28, 0002) to reach this target, otherwise their candidacies will not be considered.
  - Every resident will be given an opportunity to vote or nominate themselves as a candidate in any nearby city with the purpose of forming an electoral district. An electoral district is a city with residents from one or more smaller cities on Earth that did not have the required population.
- 5. To register as a candidate, it is necessary to fill out a personal profile on the website www.asgardia.space and to publish a short electoral program and/or video addressing potential constituents. The Administration of Asgardia retains the right to remove candidates whose electoral address contradicts the Constitution of Asgardia.

- 6. The number of candidates nominated from a single city or a district is unlimited.
- 7. A registration fee of 100 Euros is a mandatory for a mayoral candidate. The registration fee must be paid within the period from 00:00 GMT on August 1, 2018 to 23:59 GMT on September 9, 2018 (from July 17 until August 28, 0002).

- 8. Voting will take place from 00:00 GMT on August 1, 2018 (July 17, 0002) until 23:59 GMT on September 9, 2018 (August 28, 0002). Every resident can vote for one candidate only in their city or district. Only direct voting is counted in calculating the votes. Residents who participate in the voting are not permitted to give their vote to another resident or vote on behalf of another resident.
- 9. The final list of elected candidates will be affirmed by the Head of Nation after CEC protocol is presented.
- 10. A mayor's authority includes representation of Asgardia in their city (district), city (district) budgeting, verification of city (district) citizens as well as other duties in accordance with the law of Parliament.
- 11. A Mayor's term of office is established for at least one calendar year with the possibility of reelection in accordance with the law of Parliament when it is established.
- 12. Combining the position of a mayor with participation in other government agencies of Asgardia is not permitted.
