On the results of Second By-Election to Asgardia's First Parliament

16 CAPRICORNUS 0004 (17 DECEMBER 2020)

The Central Electoral Commission, under the chairmanship of Markus Gronbach, has reviewed the report of the Counting Commission under the chairmanship of Saltanat Shalakhmetova.

Based on the Counting Commission's report, the results of the voting in the second by-election to the First Parliament of Asgardia have been summed up:

- The CEC confirms that the verification of the documents of 55 candidates who have met the mandatory conditions in accordance with the Provision of the CEC on by-election to the first Parliament of Asgardia and review of the identification documents of the candidates have been deemed valid.
- No major falsification or other instances of gross misconducts have been uncovered.
- In accordance with the Regulations of the election to the Parliament of Asgardia, the CEC begins the mandatory international criminal background check, which will begin 72 hours following the publication of this decree. If a candidate refuses the background check, and thus removes their candidacy, they must immediately notify the CEC by sending a message to elections@asgardia.space using subject «Criminal Background Check».

The candidate can also be rejected after the criminal background check or should the CEC be presented with the facts of violation of election regulations and/or the Constitution of Asgardia. Acceptance of and adherence to the Constitution of Asgardia are mandatory for all the citizens of Asgardia.

On the consideration of results of the second By-Election to Asgardia's First Parliament

16 CAPRICORNUS 0004 (17 DECEMBER 2020)

Members of Counting Commission were presented with logfiles (the files that contain all the relevant data to verify votes, e.g. IP-addresses) of the final voting period for the parliamentary by-election of Asgardia, which took place during the period 10 - 12 Capricornus 0004 (11-13 December 2020).

A review of gross violations such as vote falsification has been conducted to ensure that no candidates used illegal technological manipulations for increasing the number of votes they


receive and/or directly or indirectly acted in violation of the Constitution of Asgardia.

The logfiles of 55 candidates have been reviewed. As of the moment, these candidates have met the mandatory conditions on accordance with the Provision of the Central Electoral Commission (CEC) on by-elections to the first Parliament of Asgardia.

This review included the verification of data in candidate profiles based on the submitted identity documents.

As the result of the review, at the moment of the drafting of this protocol in accordance with the CEC announcement on the closing of the voting period, 55 candidate applications have been presented to the CEC for consideration.
