### PROTOCOL OF THE THIRTEENTH MEETING OF THE SUPREME SPACE COUNCIL OF ASGARDIA

**FORMAT OF THE MEETING:**

Physical presence of members of the SSC.

- 1) On the work of the IV Executives' Congress of Asgardia in Dubai.

**Speakers:** Members of the SSC discussed the current outcome of the event and noted that the Congress was being very successful, with interactions between Executive Members demonstrating a high degree of commitment to deliver results.

**Decision taken:**

To give a positive assessment of the IV Executives' Congress of Asgardia, its results, and each of its component parts. Continue to use a similar multiformat for future Asgardia Executive Congress events. The specific positives included:

- a) Reports of the Ministers of the Government and the Chairmen of the Parliamentary Committees demonstrated professionalism of the speakers, and a clear understanding of the importance of delivering specific, measurable objectives. Speakers also displayed team spirit, and had invested time and effort into their presentations.
- b) The physical meetings add depth to the quality of working relationships in the Executive.
- c) The ceremonial accreditation procedure with the participation of the top executives of Asgardia, conducted with state symbols, continues to provide a strong foundation for civic traditions of patriotism, cooperation and cohesion of the Executive.

**Decision taken unanimously.**

**2) Action relating to the former Senior Advisor to the Administration of the Head of Nation of Asgardia, Mr Markus Gronbach.**

**Speakers:** Accountant of the Asgardia headquarters in Austria - "Asgardia Terra Ark" (ATA) NGO - Werner Kanyak provided brief information on the unauthorized withdrawal of a significant amount of funds, approximately €165,000, from the ATA account by its secretary and account administrator, Mr Markus Gronbach, and on the subsequent closure of this "ATA" NGO bank account by him a day before his dismissal by decision of the ATA Board of Directors on 27 June 2025. It was stated that the actions of Mr Gronbach caused significant financial damage to Asgardia, and the corresponding official lawsuits seeking redress and criminal prosecution have already been officially filed in the jurisdiction of Austria.

**Decision taken:**

To mete out the highest degree of punishment to Mr Markus Gronbach, previously dismissed by Decree of the Head of Nation No. 88 dated 20 September 2025 from the position of Senior Advisor to the Administration of the Head of Nation due to loss of trust and confidence pursuant to Article 33, Item 5 of the Constitution of Asgardia – digital ostracism – and to expel him from the ranks of Asgardians for the rest of his life.

The voting was as follows:

- Dr Ashurbeyli - IN FAVOUR.
- Mr Lembit Öpik - IN FAVOUR.
- Mr Dorin Prunariu - IN FAVOUR.

- Mr Yun Zhao deferred to the majority view on the basis that he must maintain neutrality in case of an appeal by Mr Gronbach to the Supreme Justice. To vote in favour of the proposal could be regarded as prejudicial to Mr Gronbach's chance of an impartial hearing in the Supreme Court.
- Ms Lena De Winne abstained on the basis that she did not consider herself sufficiently informed of the facts of the case.

**Thus, the decision was made by three votes in favour with two abstentions.**

### **3) Action relating to the Member of Parliament of Asgardia, Mr Daniel Ekwevi.**

**Speaker:** In accordance with Article 33, Item 5 of the Constitution of Asgardia, Lembit Öpik proposed to apply the highest degree of punishment in the form of digital ostracism to Mr Daniel Ekwevi, on the basis that he has repeatedly violated behavioural standards as specified in the Constitution of Asgardia.

Specifically, Mr Öpik presented material evidence of these violations, one of which is available for inspection in Annex No.1 and represents an example of exchanges between Mr Öpik and Mr Ekwevi. Mr Öpik considered Mr Ekwevi's actions a potential threat to the reputation of Asgardia on the basis that he was promoting financial activities without the authorisation of the Chair of Parliament, or anyone else. Mr Ekwevi's dismissive, aggressive, and menacing responses led Mr Öpik to the firm conclusion that Mr Ekwevi had no intention of altering his current mode of operation. In this regard, Mr. Öpik stated that he had no other choice but to apply the highest degree of punishment to Mr Ekwevi in accordance with Article 33, Item 5 of the Constitution of Asgardia — digital ostracism.

#### **Decision taken:**

To mete out the highest degree of punishment to Mr Daniel Ekwevi in accordance with Article 33, Item 5 of the Constitution of Asgardia – digital ostracism and expulsion from the ranks of Asgardians for the rest of his life, whereby he is automatically expelled from the Parliament of Asgardia.

#### **Decision taken unanimously.**
