## **Regulation of the Government of ASGARDIA** *No 3 dated 02 Sagittarius 0005 (November 6, 2021)*

### **On National Representatives of Asgardia**

#### **Preamble**

In accordance with the Constitution of Asgardia (Article 34 item 10), the Civil Servants Act (Section 5 item 5, Section 6 item 9, and Section 7 item 6), approved by Decree 42 of the Head of Nation of Asgardia on 27 Aries 0004 (March 23, 2020), and on the basis of the "Governance Structure" approved by the decision made at the X Parliament Sitting on 17-19 Capricornus 0004 (December 18-20, 2020), I hereby endorse the Government Regulation "On National Representatives of Asgardia".

#### **1. General Terms and Provisions.**

- 1.1. Pursuant to the Civil Servants Act, the following structure for Asgardian national representatives on planet Earth territories is introduced to implement the representation of Asgardia:
  - Continental Representatives
  - Subcontinental Representatives
  - Country Representatives
  - Regional Representatives
  - City Representatives
- 1.2. It is possible to combine positions as per the structure. Procedures and rationale for combining positions will be formalized in separate resolutions (acts).
- 1.3. Further on, detailed powers and authority and official duties of national representatives will be established additionally by separate decisions.

#### **2. Continental Representatives**

- 2.1. A Continental Representative represents the interests of Asgardia on a particular continent of planet Earth.

- 2.2. There are 6 Continental Representatives, based on the number of recognized planet Earth continents and the Civil Servants Act: Eurasia (Moscow), North America (New York), South America (Rio de Janeiro), Australia and Oceania (Sydney), Africa (Abuja), and Antarctica (Asgard).
- 2.3. Continental Representatives shall be appointed and dismissed by the Head of Nation, as per the Constitution of Asgardia (Article 32 item 9).
- 2.4. Continental Representatives coordinate and manage the activity of Subcontinental Representatives, if any are stipulated for a given continent.
- 2.5. Continental Representatives set and manage the budget at their level as determined by Parliament.

### **3. Subcontinental Representatives**

- 3.1. A Subcontinental Representative represents the interests of Asgardia in a subcontinental region (group of countries, country) located within the territory of a continent of planet Earth.
- 3.2. The number of Subcontinental Representatives and their cities of placement are determined by the Civil Servants Act and the present Government Regulation: Beijing, Delhi, Montreal, Mexico City, Buenos Aires.
- 3.3. Subcontinental Representatives shall be appointed and dismissed by Decree of the Head of Nation as advised by a Continental Representative or a simple majority of the region's Country Representatives.
- 3.4. Subcontinental Representatives shall coordinate and manage the activity of Country Representatives within the subcontinent assigned to them.

### **4. Country Representatives**

- 4.1. A Country Representative represents the interests of Asgardia within the territory of a particular country on planet Earth.
- 4.2. The number of country representative offices and their cities of placement are determined by the number of priority countries for Asgardia, whether recognized or unrecognized. Current priority countries are the following: Australia, Austria, Bangladesh, Belgium, Brazil, the UK, Germany, Indonesia, India, Spain, Italy, Canada, China, Mexico, Nigeria, Pakistan, Russia, the USA, Turkey, the Philippines, France, Japan.  
This list is not exhaustive and may be expanded.
- 4.3. Country Representatives shall be appointed and dismissed by the Head of Nation as advised by a Continental Representative or a simple majority of the country's City Representatives.
- 4.4. Country Representatives coordinate and manage the activity of Regional Representatives within the country or directly via City Representatives.
- 4.5. Country Representatives act as Asgardia's representatives in the host country.
- 4.6. Country Representatives manage the budget at their level as determined by Parliament.

## **5. Regional Representatives**

- 5.1. Regional Representatives represent the interests of Asgardia in the region formed based on and considering the administrative-territorial structure established in planet Earth countries, where it is deemed appropriate.
- 5.2. The number of Regional Representatives and their cities of placement are determined based on the administrative-territorial structure established in planet Earth countries by separate Government decisions.
- 5.3. Regional Representatives shall be appointed and dismissed by Country Representatives as advised by City Representatives.
- 5.4. Regional Representatives coordinate and manage the activity of City Representatives within their respective territories.

## **6. City Representatives**

- 6.1. City Representatives represent the interests of Asgardia in planet Earth cities with a population over 5000 people or in agglomerations (combining several localities with a population less than 5000 people to reach the minimum threshold of 5000 people).
- 6.2. The number of City Representatives is determined by the Government of Asgardia based on the number of planet Earth cities and agglomerations.
- 6.3. City Representatives shall be elected and dismissed by Asgardian residents (citizens) residing in the respective cities and agglomerations by a simple majority of at least 10 people as a rule.
- 6.4. City Representatives set and manage the budget at their level as determined by Parliament.
- 6.5. City Representatives are the backbone of the Nation: they are chief officials and primary local self-governance agents. Only Earth cities are represented by stars on the celestial map of Asgardia.
- 6.6. Status definitions:  
A City Representative is a Resident of Asgardia, a civil servant, a primary local self-governance agent residing in a city or agglomeration with at least 5,000 terrestrial residents and a minimum of 10 Asgardian Residents.  
An Acting City Representative is a Resident of Asgardia or an Asgardian residing in a city or agglomeration with at least 5,000 terrestrial residents and less than 10 Asgardian Residents.

## **7. Territorial Arrangement Principles**


- 7.1. To enable the activity of Continental, Subcontinental, Country, Regional, and City Representatives, a governmental registry of territorial units shall be established and adopted according to the national representation structure.

7.2. Territorial division shall be carried out primarily based on and considering the administrative-territorial structure of terrestrial countries established.

7.3. Changing agglomeration boundaries for national representatives is possible at the initiative of Asgardians living within the respective territory by their vote and taking into account the opinion of local self-governance bodies and/or higher Asgardian government bodies.
