PROTOCOL OF THE FIFTEENTH MEETING OF THE SUPREME SPACE COUNCIL OF ASGARDIA

FORMAT OF THE MEETING:

Physical presence of the SSC members.

DATE OF MEETING:

24-25 Virgo 0010 (8-9 August 2026).

LOCATION:

Corfu Island, Greece.

AGENDA OF THE MEETING:

1) On seeking recognition of Asgardia's independence.

Approve the candidacy of Nigel Evans as Head of the Commission for Recognising Asgardia's Independence for the period until 31.12.2026. Members of the Supreme Space Council are to submit candidates for engaging in the Commission.

Decision taken unanimously.

2) On founding IGO— the Intergovernmental Organisation ‘Asgardia’.

Proceed with the establishment of the Intergovernmental Organisation (IGO) ‘Asgardia’ as a step towards Asgardia’s international legal personality. Instruct the Prime Minister and the Office of the Administration to draw up a roadmap and submit it to the Head of Nation.

Decision taken unanimously.

3) On Asgardia mobile app.

Oblige all civil servants in Asgardia to use the Asgardia mobile app and to submit their comments and suggestions for its improvement to the Office of the Administration.

Decision taken unanimously.

4) On the Supreme Justice of Asgardia.

Following the discussion of the proposed candidates for the vacant post of Supreme Justice of Asgardia from among the current panel of judges, recommend that the Head of Nation appoint Ms Ana Maria Moure Pino as Supreme Justice of Asgardia by his decree.

Decision taken unanimously.

5) On the budget of Asgardia (ATA).

Take note of the report on the Asgardian budget for 2010 (2026), presented by the Head of Administration. Allocate additional funds for the Government of Asgardia.

Decision taken unanimously.

6) On termination of Asgardia's membership in the United Nations Economic and Social Council (ECOSOC).

Take note of the termination of Asgardia’s ECOSOC membership due to the actions of Asgardia’s official representatives in ECOSOC - former Prime Minister Lena De Winne and former Senior Advisor in the Administration Markus Gronbach, both subsequently dismissed. Instruct the Head of Administration to prepare an appeal to ECOSOC for resuming interaction. Instruct the ROOM journal Editor-in-Chief, Mr Clive Simpson, to publish an article in the next issue (by 12 October 2026) focusing on the benefits of the relationship between Asgardia and ECOSOC.

Decision taken unanimously.

7) On Asgardia's 10th anniversary.

Hold the celebrations marking the 10th anniversary of Asgardia in Nice on 12 October 2026. Instruct the Government and Administration Offices to prepare a schedule and budget for the events.

Decision taken unanimously.
