# PROTOCOL X PARLIAMENTARY SITTING OF ASGARDIA 17-19 CAPRICORNUS 0004 (18-20 DECEMBER 2020)

### TYPE AND LOCATION

The 10th Parliamentary Sitting of Asgardia was held on 17-19 Capricornus 0004 (18-20 December 2020) in the form of digital presence, using platforms ZOOM, SLACK and the electronic voting system of Asgardia.

### **REGISTRATION AND QUORUM**

Registration was carried out on the digital platform of Asgardia.

At the time of the registration, the Parliament constituted **95** members (AMPs), who were authorized to be admitted to registration and voting.

Registration, corresponding to the report of the Mandate Commission **90** parliamentarians (AMPs), was **95**%, exceeding the required quorum total of 50% + 1 Asgardian Members of Parliament.

The quorum was achieved.
